- ☐ **Teen BTW Course:** Teenagers under the age of 18 are required to take behind-the-wheel. This consists of 7 x 50min periods of Driving and 7 x 50mins of Observation, completed alongside other students. Only two periods of instruction (Driving & Observation) are given during each session. Students under the age of 18 are required to complete 36 hours of a State Approved Driver's Education program and a 90min parent-teen safety meeting prior to receiving their driver's license.
- ☐ **Adult BTW License Waiver:** Adults aged 18 and over are eligible for adult waiver program. This consists of 7 x 50min periods of Driving and 7 x 50mins of Observation. Only two periods of instruction (Driving & Observation) are given during each session. Students aged 18 and over are also required to complete 36 hours of a State Approved Driver's Education Program prior to enrolling into this course. This waiver will remove the 60-day waiting period to apply for your license.
- ☐ **Driving Lessons:** The fee for in-car instruction is: **\$100 (1) | \$190 (2) | \$280 (3) | \$370 (4) | \$460 (5)**. Driving Lessons are 90mins each.

Teen - Behind the Wheel: The fee for in car Teen behind the wheel instruction and observation is: **\$395**

Adult - Behind the Wheel License Waiver: The fee for in car Adult behind the wheel instruction and observation is: **\$395**

Course Fees: are paid on the first session of instructions. There will be a **\$35** fee for any returned checks. The returned check fee doubles if payment arrangements are not made within a week of notification.

Refunds: Refund requests must be submitted in writing. If sessions are discontinued for any reason, tuition fee will be calculated for the past session and the balance will be paid within 4 weeks.

Replacement of Completion Paper: There will be a **\$35** fee to replace any license certificates.

Cancellations: Students must cancel or reschedule in-car lessons at least 24 hours in advance or are subjected to a \$25 Fee. The school will inform the student of any cancellation or rescheduling at least 24 hours in advance. If a student begins the course and does not maintain communication with the instructor for 30 consecutive days, the remaining sessions will be terminated, and no refund will be issued. **License**

Courses: If the instructor determines that you are not experienced enough to continue, the remaining sessions will be canceled, and a \$50 fee will be charged for the first session.

Disclosure: SA Driving School Inc does not guarantee that after taking the in-car instructions, the student will pass the state license examination or that the student can secure a license. Or that the student will be guaranteed employment upon completion of the course.
